- Besides initiatives for environment protection, the environment policy include's waste management and water management which are separately taking into account the importance of each, and policies and procedures have been formulated for these topics.

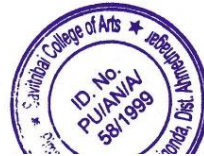
Objectives :


